# **Terms of Use**

Welcome to Plan. Please read on to learn the rules and restrictions that govern your use of our website(s), products, services, and applications (the "Services"). If you have any questions, comments, or concerns regarding these terms or the Services, please contact us at hello@getplan.co.

These Terms of Use (the "Terms") are a binding contract between you and Plan Inc.. ("Plan," "we" and "us"). You must agree to and accept all of the Terms, or you don't have the right to use the Services. Your using the Services in any way means that you agree to all of these Terms, and these Terms will remain in effect while you use the Services. These Terms include the provisions in this document, as well as those in the Privacy Policy [https://getplan.co/privacy.pdf].

# Will these Terms ever change?

We are constantly trying to improve our Services, so these Terms may need to change along with the Services. We reserve the right to change the Terms at any time, but if we do, we will bring it to your attention by placing a notice on the www.getplan.co website, by sending you an email, and/or by some other means.

If you don't agree with the new Terms, you are free to reject them; unfortunately, that means you will no longer be able to use the Services. If you use the Services in any way after a change to the Terms is effective, that means you agree to all of the changes.

Except for changes by us as described here, no other amendment or modification of these Terms will be effective unless in writing and signed by both you and us.

#### What about my privacy?

# What are the basics of using Plan?

You may be required to sign up for an account. You promise to provide us with accurate, complete, and updated information about yourself. You may not select as your Plan User ID a name that you don't have the right to use, or another person's name with the intent to impersonate that person.

You may not transfer your account to anyone else without our prior written permission. You may be required to connect your account to a third party account (e.g. Google) to use the Services (a "Connected Account"). You hereby authorize Plan to receive and/or access all information from your Connected Account necessary for Plan to provide the functionality of the Services.

You represent and warrant that you are an individual of legal age to form a binding contract (or if not, you've received your parent's or guardian's permission to use the Services and gotten your parent or guardian to agree to these Terms on your behalf).

You will only use the Services for your own use, and not on behalf of or for the benefit of any third party, and only in a manner that complies with all laws that apply to you. # Your use of the Services is subject to the following additional restrictions:

You represent, warrant, and agree that you will not contribute any Service Data or Content (each of those terms is defined below) or otherwise use the Services or interact with the Services in a manner that:

For all Service Data, you hereby grant Plan a license to translate, modify (for technical purposes, for example making sure your content is viewable on an iPhone as well as a computer) and reproduce and otherwise act with respect to such Service Data, in each case to enable us to operate the Services, as described in more detail below. This is a license only – your ownership in Service Data is not affected.

# Will Plan ever change the Services?

We're always trying to improve the Services, so they may change over time. We may suspend or discontinue any part of the Services, or we may introduce new features or impose limits on certain features or restrict access to parts or all of the Services. We'll try to give you notice when we make a material change to the Services that would adversely affect you, but this isn't always practical. Similarly, we reserve the right to remove any Content from the Services at any time, for any reason (including, but not limited to, if someone alleges you contributed that Content in violation of these Terms), in our sole discretion, and without notice.

# Does Plan cost anything?

Certain portions of the Services are currently free, but we reserve the right to charge for other portions or all Services in the future. You may not assign, delegate or transfer these Terms or your rights or obligations hereunder, or your account, in any way (by operation of law or otherwise) without Plan's prior written consent. We may transfer, assign, or delegate these Terms and our rights and obligations without consent.

Choice of Law; Arbitration. These Terms are governed by and will be construed under the laws of the State of California, without regard to the conflicts of laws provisions thereof. Any dispute arising from or relating to the subject matter of these Terms shall be finally settled in San Francisco County, California. in English, in accordance with the Streamlined Arbitration Rules and Procedures of Judicial Arbitration and Mediation Services, Inc. ("JAMS") then in effect, by one commercial arbitrator with substantial experience in resolving intellectual property and commercial contract disputes, who shall be selected from the appropriate list of JAMS arbitrators in accordance with such Rules. Judgment upon the award rendered by such arbitrator may be entered in any court of competent jurisdiction. Notwithstanding the foregoing obligation to arbitrate disputes, each party shall have the right to pursue injunctive or other equitable relief at any time, from any court of competent jurisdiction. For all purposes of these Terms, the parties consent to exclusive jurisdiction and venue in the state or federal courts located in, respectively, San Francisco County, California, or the Northern District of California. Any arbitration under these Terms will take place on an individual basis: class arbitrations and class actions are not permitted. YOU UNDERSTAND AND AGREE THAT BY ENTERING INTO THESE TERMS, YOU AND PLAN ARE EACH WAIVING THE RIGHT TO TRIAL BY JURY OR TO PARTICIPATE IN A CLASS ACTION.

<u>Miscellaneous</u>. You will be responsible for paying, withholding, filing, and reporting all taxes, duties, and other governmental assessments associated with your activity in connection with the Services, provided that the Plan may, in its sole discretion, do any of the foregoing on your behalf or for itself as it sees fit. The failure of either you or us to exercise, in any way, any right herein shall not be deemed a waiver of any further rights hereunder. If any provision of these Terms is found to be unenforceable or invalid, that provision will be limited or eliminated, to the minimum extent necessary, so that these Terms shall otherwise remain in full force and effect and enforceable. You and Plan agree that these Terms are the complete and exclusive statement of the mutual understanding between you and Plan, and that it supersedes and cancels all previous written and oral agreements, communications and other

understandings relating to the subject matter of these Terms. You hereby acknowledge and agree that you are not an employee, agent, partner, or joint venture of Plan, and you do not have any authority of any kind to bind Plan in any respect whatsoever.
